Subject : Auction of Royal Thai Consulate-General's Official Vehicle

The Royal Thai Consulate-General, Osaka wishes to sell its official vehicle through **auction** which will be conducted by bidding in verbal or written form. Details are as follows :

1. Vehicle - Toyota Alphard GL Package, engine displacement 3,500 cc., Station Wagon Black Color, 7 seats, purchased in 2010 (details as attached)

2. Current mileage (18 April 2019) - 184,076 km

3. Minimum bidding price - JPY 550,000.-

4. Auction starting date - 29 May 2019

5. Auction location - Royal Thai Consulate-General in Osaka

6. The vehicle will be sold as is. Prior to participating in the auction, the bidder must read the auction announcement and see the vehicle's conditions in person. Upon entering into the auction, it is considered that the bidder has acknowledged and agreed on the conditions and details of the vehicle auction. The bidder shall not claim nor request the Royal Thai Consulate General in Osaka to improve, change or modify the auctioned car to be in better condition.

7. The bidder must offer a price not less than the minimum price set by the Royal Thai Consulate General in Osaka. The highest bidder will be eligible to purchase the vehicle and is immediately required to pay the full amount of the auction price or pay a deposit of no less than 20 percent of the auction price at the finance department of The Royal Thai Consulate-General in Osaka with the bidder's identification documents. The Royal Thai Consulate-General in Osaka will issue a receipt of payment and the bidder must pay the remaining amount within 5 business days after the auction date. The bidder shall pick up the vehicle at the Royal Thai Consulate-General in Osaka within 10 business days after the full payment is completed.

8. The buyer is responsible for all related costs, including but not limited to, transfer fee, registration or ownership license plate change fee, transportation fee, tax and other related expenses.

9. If the bidder does not complete the full payment within the specified date, he/she will forfeit the purchase and will not be entitled to file any claim for damages or expenses.

10. Bidders must not have a conflict of interest with other bidders or act in any way to hinder the bidding process.

11. Members of the auction committee are neither eligible to bid nor assign others to be their proxy.

12. Those interested in and wanting to participate in the auction must submit their bids from April 18, 2019 to May 28, 2019, between 09.30 - 17.30 hrs (except during public holidays of the Royal Thai Consulate-General).
