

## Non-Immigrant ED Visa

### (For Students Enrolling at Private Schools in Thailand)

**Please make an appointment online [VABO] at [www.thaiconsulate-visa.jp/vabo/](http://www.thaiconsulate-visa.jp/vabo/) before visa application.**

- **Submission:** working days from 9:30-11:30 hrs. Please refer to [www.thaiconsulate.jp](http://www.thaiconsulate.jp) for the official holidays of the Royal Thai Consulate-General, Osaka.
- **Collection:** from 13:30-15:00 hrs. 2 working days from submission date in the absence of error in the application form and required documents. (Visa processing time for certain nationals listed in the guideline for visa application published on our website is 45-60 days.)

## Required Documents

1. **Passport** Original and copy
  - Passport with validity not less than 6 months
  - At least 2 blank pages left
  - One copy of bio data page
2. **Visa Application Form** ([PDF 1](#), [PDF 2](#))
  - One Visa Application Form completely filled out and signed as the same as the applicant's passport signature

### 3. One Photograph

- Size 3.5 cm × 4.5 cm
- Colour photograph taken within the last 3 months
- Attach the photograph to the Visa Application Form
- Note that the number of photographs required depending on the applicant's nationality, please check the additional required documents for Non-Japanese applicants below

### 4. Personal History ([PDF](#))

- One Personal History completely filled out and signed as the same as the applicant's passport signature

### 5. Invitation Letter issued by educational institution, school, or university in Thailand

- Must be an original invitation letter written in English or Thai (PDF or fax copy is not acceptable)
- Must have the letter head of educational institution, school or university in Thailand
- Must address to “Royal Thai Consulate-General, Osaka”
- Must contain the applicant's name / purpose of visit / date of entry / length of stay and type of visa
- Must have the official seal and include the autograph of the authorised representative (electronic signature is not acceptable)

### 6. Recommendation Letter issued by educational institution, school, or university in Japan

- Must be an original Recommendation Letter written in English (PDF or fax copy is not acceptable)
- Must have the letter head of educational institution, school or university
- Must address to “Royal Thai Consulate-General, Osaka”
- Must contain the applicant's name / purpose of visit / date of entry / length of stay and type of visa
- Must have the official seal and include the autograph of the authorised representative (electronic signature is not acceptable)

※ In case that the Recommendation Letter from educational institution, school, or university in Japan cannot be shown, **an original guarantee letter must be presented together with a copy of guarantor's passport or driving license duly signed by the guarantor**

#### Guarantee Letter ([PDF](#))

- A guarantor must be 20 years of age or older, must be able to confirm the applicant's personal attributes. A guarantor must be available to be contacted by the Consulate-General and must not be a person who will accompany the applicant to Thailand
- A guarantor who are not Japanese national must provide a copy of passport and residence card (front and backside) \* (legally residing in Japan with permanent residence)
- In the English Guarantee Letter, a guarantor must sign as the same as the guarantor's identification document signature
- Japanese guarantor who prefers to use driver license, please sign as the same as signature in the guarantor letter on the copy of driver license (front and backside)

### 7. Approval Letter issued by the Office of Private Education Commission of Thailand (OPEC)

- Must be an original Approval Letter (PDF or fax copy is not acceptable)
- For students enrolling in international schools/universities or graduate students in which those schools/universities have already registered with the Office of Private Education Commission of Thailand, it is not necessary to show an approval letter
- Must contain applicant's name and type of visa

### 8. For applicant aged under 20 years, please provide the following documents:

**8.1 An original guarantee letter from parents or guardians** must be presented together with a copy of guarantor's passport or driving license duly signed by the guarantor

#### Guarantee Letter ([PDF](#))

- A guarantor must be 20 years of age or older, must be able to confirm the applicant's personal attributes. A guarantor must be available to be contacted by the Consulate-General and must not be a person who will accompany the applicant to Thailand

- A guarantor who are not Japanese national must provide a copy of passport and residence card (front and backside) \* (legally residing in Japan with permanent residence)
- In the English Guarantee Letter, a guarantor must sign as the same as the guarantor's identification document signature
- Japanese guarantor who prefers to use driver license, please sign as the same as signature in the guarantor letter on the copy of driver license (front and backside)

### 8.2 Official documents proving family relationship with the applicant

- For Japanese national, an original Household Registration (KOSEKITOHON) issued within 3 months
- For Non-Japanese nationality, Residence Records (JUMINHYO) or birth certificate of your country with English translation is required

### 9. One copy of confirmed airline ticket paid in full or ticket reservation confirmation

- The confirmed airline ticket paid in full or ticket reservation confirmation must be issued by airline or travel company and must contain the applicant's name, flight number and date arrival

### 10. Foreign prospective students who will study at a Thai university must provide an original criminal record in a sealed envelope

## Additional Required Documents for Non-Japanese Applicants

### 11. One copy of residence card (front and backside)

(On the applying date, please present the original document of identification)

- Valid for at least 3 months
- For those who are currently applying for renewal of residence card, please submit a copy of acceptance of renewal issued by the Immigration Bureau of Japan

### 12. Additional Colour Photograph(s) affixed to the application form

(Only for the applicant from the listed countries below)

- Applicant with nationality of No. 1-28, please provide 3 application forms and 3 photographs
- Applicant with nationality of No. 29-30, please provide 4 application forms and 4 photographs
