Please make an appointment online [VABO] at www.thaiconsulate-visa.jp/vabo/ before visa application.

- **Submission:** working days from 9:30-11:30 hrs. Please refer to www.thaiconsulate.jp for the official holidays of the Royal Thai Consulate-General, Osaka.
- **Collection:** from 13:30-15:00 hrs. 2 working days from submission date in the absence of error in the application form and required documents. (Visa processing time for certain nationals listed in the guideline for visa application published on our website is 45-60 days.)

Required Documents

- 1. Passport** Original and copy
 - Passport with validity not less than 6 months for Single Entry
 - Passport with validity not less than 12 months for Multiple Entries
 - At least 2 blank pages left
 - One copy of bio data page
- 2. Visa Application Form** ([PDF 1](#), [PDF 2](#))
 - One Visa Application Form completely filled out and signed as the same as the applicant's passport signature

3. One Photograph

- Size 3.5 cm × 4.5 cm
- Colour photograph taken within the last 3 months
- Attach the photograph to the Visa Application Form
- Note that the number of photographs required depending on the applicant's nationality, please check the additional required documents for Non-Japanese applicants below

4. Personal History ([PDF](#))

- One Personal History completely filled out and signed as the same as the applicant's passport signature

5. Invitation Letter issued by a Thai national who is the applicant's spouse or the parent of the applicant who is under 20 years of age with parental authority [[PDF 1](#) , [PDF 2](#)]

6. Additional Required Documents of Thai National (Please submit all A-C documents)

A. A copy of Thai identification card (Thai ID card)

B. A copy of Thai national's passport photo page (if available)

C. A copy of the Thai national's House Registration

7. One copy of official documents proving family relationship with the Thai national

- For spouse of a Thai national, must submit a copy of Registration of Marriage
(สำเนาทะเบียนสมรส หรือ สำเนาทะเบียนฐานะแห่งครอบครัว (สมรส))
- For parent of the lawful Thai children / dependent who is under 20 years of age with parental authority, must submit a copy of Birth Certificate
(สำเนาสูติบัตรของบุคคลสัญชาติไทย)

8. One original family registration certificate of Japan (KOSEKITOHON)

- Must be issued within 3 months
- For non-Japanese national and his/her non-Japanese family members, please submit residence certificate (JUMINHYOU)

9. One original guarantee letter must be presented, together with a copy of guarantor's passport or driving license duly signed by the guarantor

Guarantee Letter ([PDF](#))

- A guarantor must be twenty (20) years of age or older, must be able to confirm the applicant's personal attributes. A guarantor must be available to be contacted by the Consulate-General and must not be a person who will accompany the applicant to Thailand
- A guarantor who are not Japanese national must provide a copy of passport and residence card (front and backside) *Guarantor must be Japanese or non-Japanese who has permanent residence in Japan.)
- A guarantor must sign as the same as the guarantor's identification document signature
- Japanese guarantor who prefers to use driver license, please sign as the same as signature in the guarantor letter on the copy of driver license (front and backside)

10. One copy of confirmed airline ticket paid in full or ticket reservation confirmation

- The confirmed airline ticket paid in full or ticket reservation confirmation must be issued by airline or travel company and must contain the applicant's name, flight number and date arrival

Additional Required Documents for Non-Japanese Applicants**11. One copy of residence card (front and backside)**

(On the applying date, please present the original document of identification)

- Valid for at least 3 months
- For those who are currently applying for renewal of residence card, please submit a copy of acceptance of renewal issued by the Immigration Bureau of Japan

12. Additional Colour Photograph(s) affixed to the application form

(Only for the applicant from the listed countries below)

- Applicant with nationality of No. 1-28, please provide 3 application forms and 3 photographs
- Applicant with nationality of No. 29-30, please provide 4 application forms and 4 photographs
