

Non-Immigrant O Visa (For Volunteer in Thailand)

Please make an appointment online [[VABO](#)] at www.thaiconsulate-visa.jp/vabo/ before visa application.

- **Submission:** working days from 9:30-11:30 hrs. Please refer to www.thaiconsulate.jp for the official holidays of the Royal Thai Consulate-General, Osaka.
- **Collection:** from 13:30-15:00 hrs. 2 working days from submission date in the absence of error in the application form and required documents. (Visa processing time for certain nationals listed in the guideline for visa application published on our website is 45-60 days.)

Notice	<ul style="list-style-type: none">● Applicant must enter Thailand on the date specified in the airline ticket or ticket reservation confirmation● Upon arrival to Thailand, the period of stay is granted by an immigration officer in accordance with the type of visa; travelers who wish to stay longer than the granted period must file an application for permission of extension of stay at offices of the Immigration Bureau of Thailand; the extension of stay as well as the change of certain type of visa is solely at the discretion of the Immigration officer in Thailand● In case that visa application is rejected, the visa fee will not be refunded and the submitted documents will not be returned to the applicant● The following required documents are subject to change without prior notice● The Royal Thai Consulate-General, Osaka reserves the right to request additional documents as deemed necessary and reserves the right to reject an application without providing any reasons● Fraud or misrepresentation can result in permanent visa ineligibility		

Required Documents

- 1. Passport** Original and copy
 - Passport with validity not less than 6 months
 - At least 2 blank pages left
 - One copy of bio data page
- 2. Visa Application Form** ([PDF 1](#), [PDF 2](#))
 - One Visa Application Form completely filled out and signed as the same as the applicant's passport signature

3. One Photograph

- Size 3.5 cm × 4.5 cm
- Colour photograph taken within the last 3 months
- Attach the photograph to the Visa Application Form
- Note that the number of photographs required depending on the applicant's nationality, please check the additional required documents for Non-Japanese applicants below

4. Personal History ([PDF](#))

- One Personal History completely filled out and signed as the same as the applicant's passport signature

5. Invitation Letter or Acceptance Letter for Volunteer from Non-governmental Organization / Association / Foundation / Charity in Thailand

- Must be an original Invitation Letter written in English (PDF or fax copy is not acceptable)
- Must have the letter head of the Non-governmental Organization / Association / Foundation / Charity / Institution in Japan
- Must address to “Royal Thai Consulate-General, Osaka”
- Must contain the applicant's name / purpose of entry / plan of activities / date of entry/ length of stay / type of visa
- Must sign by the authorized person(s) (electronic signature is not acceptable) together with a copy of ID card or passport's photo page

6. One copy of registration or license of the Non-governmental Organization / Association / Foundation / Charity in Thailand

7. Recommendation Letter issued by the Non-governmental Organization / Association / Foundation / Charity / Institution in Japan

- Must be an original Recommendation Letter written in English (PDF or fax copy is not acceptable)
- Must have the letter head of the Non-governmental Organization / Association / Foundation / Charity / Institution in Japan
- Must address to “Royal Thai Consulate-General, Osaka”
- Must contain the applicant's name / purpose of entry / plan of activities /date of entry/ length of stay / type of visa
- Must sign by the authorized person(s) (electronic signature is not acceptable) whose name(s) listed in the Non-governmental Organization / Association / Foundation / Charity / Institution in Japan and include the seal of the Non-governmental Organization / Association / Foundation / Charity / Institution

※ In case that the Recommendation Letter from Non-governmental Organization / Association / Foundation / Charity / Institution in Japan cannot be shown, **an original guarantee letter must be presented, together with a copy of guarantor's passport or driving license duly signed by the guarantor**

Guarantee Letter ([PDF](#))

- A guarantor must be 20 years of age or older, must be able to confirm the applicant's personal attributes. A guarantor must be available to be contacted by the Consulate-General and must not be a person who will accompany the applicant to Thailand
- A guarantor who are not Japanese national must provide a copy of passport and residence card (front and backside) * (legally residing in Japan with permanent residence)
- In the English Guarantee Letter, a guarantor must sign as the same as the guarantor's identification document signature
- Japanese guarantor who prefers to use driver license, please sign as the same as signature in the guarantor letter on the copy of driver license (front and backside)

8. One copy of confirmed airline ticket paid in full or ticket reservation confirmation

- The confirmed airline ticket paid in full or ticket reservation confirmation must be issued by airline or travel company and must contain the applicant's name, flight number and date arrival

9. In case of applying the Non-Immigrant O Visa (Volunteer) for the second time, please submit additional required documents

- Acceptance Letter from Competent Authority (Government Agency) or Local Government (prefecture / city / ward) with the details of the applicant's name who is going to be a volunteer in Non-governmental Organization / Association / Foundation / Charity in Thailand
- In case that the Acceptance Letter from Competent Authority (Government Agency) or Local Government (prefecture / city / ward) cannot be shown, one copy of valid Work Permit or one copy of the Letter of Consideration of Work Permit issued by the Department of Employment, Ministry of Labour of Thailand (WP3), issued within 3 months must be presented

Additional Required Documents for Non-Japanese Applicants

10. One copy of residence card (front and backside)

(On the applying date, please present the original document of identification)

- Valid for at least 3 months
- For those who are currently applying for renewal of residence card, please submit a copy of acceptance of renewal issued by the Immigration Bureau of Japan

11. Additional Colour Photograph(s) affixed to the application form

(Only for the applicant from the listed countries below)

- Applicant with nationality of No. 1-28, please provide 3 application forms and 3 photographs
- Applicant with nationality of No. 29-30, please provide 4 application forms and 4 photographs
