

## Non-Immigrant O Visa (For Pensioner / Retirement in Thailand)

**Please make an appointment online [[VABO](#)] at [www.thaiconsulate-visa.jp/vabo/](http://www.thaiconsulate-visa.jp/vabo/) before visa application.**

- **Submission:** working days from 9:30-11:30 hrs. Please refer to [www.thaiconsulate.jp](http://www.thaiconsulate.jp) for the official holidays of the Royal Thai Consulate-General, Osaka.
- **Collection:** from 13:30-15:00 hrs. 2 working days from submission date in the absence of error in the application form and required documents. (Visa processing time for certain nationals listed in the guideline for visa application published on our website is 45-60 days.)

<b>Qualifications</b>	<ul style="list-style-type: none"><li>● Must be 50 years of age or over on the date of applying visa</li><li>● Must not be prohibited from entering Thailand</li><li>● Must be Japanese or must have residence in Japan</li><li>● <b>Employment in Thailand is strictly prohibited</b></li></ul>		
<b>Notice</b>	<ul style="list-style-type: none"><li>● Applicant must enter Thailand on the date specified in the air ticket or ticket reservation confirmation</li><li>● Upon arrival to Thailand, the period of stay is granted by an immigration officer in accordance with the type of visa; travelers who wish to stay longer than the granted period must file an application for permission of extension of stay at offices of the Immigration Bureau of Thailand</li><li>● In case that visa application is rejected, the visa fee will not be refunded and the submitted documents will not be returned to the applicant</li><li>● The following required documents are subject to change without prior notice</li><li>● The Royal Thai Consulate-General, Osaka reserves the right to request additional documents as deemed necessary and reserves the right to reject an application without providing any reasons</li><li>● Fraud or misrepresentation can result in permanent visa ineligibility</li></ul>		

### Required Documents

- 1. Passport** Original and copy
  - Passport with validity not less than 6 months
  - At least 2 blank pages left
  - One copy of bio data page
- 2. Visa Application Form** ([PDF 1](#), [PDF 2](#))
  - One Visa Application Form completely filled out and signed as the same as the applicant's passport signature

### 3. One Photograph

- Size 3.5 cm × 4.5 cm
- Colour photograph taken within the last 3 months
- Attach the photograph to the Visa Application Form
- Note that the number of photographs required depending on the applicant's nationality, please check the additional required documents for Non-Japanese applicants below

### 4. Personal History ([PDF](#))

- One Personal History completely filled out and signed as the same as the applicant's passport signature

### 5. One copy of confirmed airline ticket paid in full or ticket reservation confirmation

- The confirmed airline ticket paid in full or ticket reservation confirmation must be issued by airline or travel company and must contain the applicant's name, flight number and date arrival

### 6. One original guarantee letter with a copy of guarantor's passport or driving license duly signed by the guarantor

#### Guarantee Letter ([PDF](#))

- A guarantor must be 20 years of age or older, must be able to confirm the applicant's personal attributes. A guarantor must be available to be contacted by the Consulate-General and must not be a person who will accompany the applicant to Thailand
- A guarantor who are not Japanese national must provide a copy of passport and residence card (front and backside) \* (legally residing in Japan with permanent residence)
- In the English Guarantee Letter, a guarantor must sign as the same as the guarantor's identification document signature
- Japanese guarantor who prefers to use driver license, please sign as the same as signature in the guarantor letter on the copy of driver license (front and backside)

### 7. One original and one copy of financial statement

(Please choose one of the following documents from A.-C.)

- A. Original income or pension certificate with the latest update on transfer notice of income/pension in total of not less than **65,000 Baht per month**; or
  - B. Original bank statement showing a deposit of the amount equal to and not less than **800,000 Baht per month** (Being able to confirm for the past 3 months including the month of submitting visa application); or
  - C. Original bank statement written in English language with an annual income or pension in total of not less than **800,000 Baht**
- Must be issued within 3 months

### 8. One original family registration certificate of Japan (KOSEKITOHON)

- Must be issued within 3 months
- In case of foreigner, please submit residence certificate (JUMINHYOU)

### 9. One original Medical Certificate

- Must be original Medical Certificate written in English language confirming that the applicant is in good health and does not have any serious illness
- Must be issued within 3 months

### 10. One original and one copy of health insurance policy

- Must issue by insurance company in Thailand, Japan or other country
- Must cover all the period of stay in Thailand
- Must cover not the medical treatment of not less than 40,000 Baht for out-patient benefit and not less than 400,000 Baht of in-house patient benefit
- Must cover with a minimum coverage of 50,000 USD including medical treatment related to COVID-19

## **Additional Required Documents for Non-Japanese Applicants**

### **11. One copy of residence card or certificate of alien registration**

(On the applying date, please present the original document of identification)

- Valid for at least 3 months
- For those who are currently applying for renewal of residence card, please submit a copy of acceptance of renewal issued by the Immigration Bureau of Japan

### **12. Additional Colour Photograph(s) affixed to the application form**

(Only for the applicant from the listed countries below)

- Applicant with nationality of No. 1-28, please provide 3 application forms and 3 photographs
- Applicant with nationality of No. 29-30, please provide 4 application forms and 4 photographs
