

## Non-immigrant Media Visa (For Movie / Filming)

**Please make an appointment online [VABO] at [www.thaiconsulate-visa.jp/vabo/](http://www.thaiconsulate-visa.jp/vabo/) before visa application.**

- **Submission:** working days from 9:30-11:30 hrs. Please refer to [www.thaiconsulate.jp](http://www.thaiconsulate.jp) for the official holidays of the Royal Thai Consulate-General, Osaka.
- **Collection:** from 13:30-15:00 hrs. 2 working days from submission date in the absence of error in the application form and required documents. (Visa processing time for certain nationals listed in the guideline for visa application published on our website is 45-60 days.)

<b>Notice</b>	<ul style="list-style-type: none"><li>● Applicant must enter Thailand on the date specified in the airline ticket or ticket reservation confirmation</li><li>● Upon arrival to Thailand, the period of stay is granted by an immigration officer in accordance with the type of visa; travelers who wish to stay longer than the granted period must file an application for permission of an extension of stay at the offices of the Immigration Bureau of Thailand; the extension of stay as well as the change of certain type of visa is solely at the discretion of the Immigration officer in Thailand</li><li>● In case the visa application is rejected, the visa fee will not be refunded and the submitted documents will not be returned to the applicant</li><li>● The following required documents are subject to change without prior notice</li><li>● The Royal Thai Consulate-General, Osaka reserves the right to request additional documents as deemed necessary and reserves the right to reject an application without providing any reasons</li><li>● Fraud or misrepresentation can result in permanent visa ineligibility</li></ul>		

### Required Documents

- 1. Passport** Original and copy
  - Validity not less than 6 months
  - At least 2 blank pages left
  - One copy of bio data page
- 2. Visa Application Form** ([PDF 1](#), [PDF 2](#))
  - One Visa Application Form completely filled out and signed as the same as the applicant's passport signature
- 3. One Photograph**
  - Size 3.5 cm × 4.5 cm
  - Colour photograph taken within the last 3 months
  - Attach the photograph to the Visa Application Form
  - Note that the number of photographs required depending on the applicant's nationality, please check the additional required documents for Non-Japanese applicants below

- 4. Personal History** ([PDF](#))
  - One Personal History completely filled out and signed as the same as the applicant's passport signature
- 5. Approval Letter issued by the Thailand Film Office, Office of Tourism Development, Ministry of Tourism and Sports of Thailand**

- 6. Invitation Letter issued by prospective employer in Thailand**
  - Must be an original invitation letter written in English (PDF or fax copy is not acceptable)
  - Must have the company's letter head
  - Must address to "Royal Thai Consulate-General, Osaka"
  - Must contain the applicant's name / assignment's position in Thailand / purpose of entry / date of entry / length of stay / type of visa
  - Must be signed by the authorized person(s) (electronic signature is not acceptable) whose name(s) listed in the company's registration (Copy of the company's registration issued by the Ministry of Commerce of Thailand within 6 months is required) and include company's seal
  - In case that a signature of authorized person(s) in the letter of invitation is absent, a letter of power of attorney authorizing other person(s) to act on his/her behalf must be submitted upon submitting the visa application
- 7. One copy of company's registration issued by the Ministry of Commerce of Thailand**
  - Must be issued within 6 months
- 8. Recommendation Letter issued by the current employer / organization in Japan**
  - Must be an original Recommendation Letter written in English (PDF or fax copy is not acceptable)
  - Must have the company's letter head
  - Must address to "Royal Thai Consulate-General, Osaka"
  - Must contain the applicant's name / assignment's position / responsibilities / salary / date of entry / length of stay and type of visa
  - Must be signed by the authorized person(s) (electronic signature is not acceptable) whose name(s) listed in the company's registration and included company's seal
- 9. One copy of the confirmed airline ticket paid in full or ticket reservation confirmation**
  - The confirmed airline ticket paid in full or ticket reservation confirmation must be issued by the airline or travel company and must contain the applicant's name, flight number, and date of arrival

### **Additional Required Documents for Non-Japanese Applicants**

- 10. One copy of residence card** (front and backside)  
(On the application date, please present the original document of identification)
  - Valid for at least 3 months
  - For those who are currently applying for renewal of residence card, please submit a copy of acceptance of renewal issued by the Immigration Bureau of Japan
- 11. The original company's registration issued by the Ministry of Justice of Japan**  
(Only the listed countries below)
  - Must be issued within 6 months
- 12. Additional Colour Photograph(s) affixed to the application form**  
(Only for the applicant from the listed countries below)
  - Applicant with a nationality of No. 1-28, please provide 3 application forms and 3 photographs
  - Applicant with a nationality of No. 29-30, please provide 4 application forms and 4 photographs
