#### 3. One Photograph

- Size  $3.5 \text{ cm} \times 4.5 \text{ cm}$
- Colour photograph taken within the last 3 months
- Attach the photograph to the Visa Application Form

#### 4. Personal History

One Personal History completely filled out and signed as the same as the applicant's passport signature

### 5. Invitation Letter issued by educational institution in Thailand

- Must be an original invitation letter written in Thai or English (PDF or fax copy is not acceptable)
- Must have the letter head of educational institution in Thailand
- Must address to "Royal Thai Consulate-General, Osaka"
- Must contain the applicant's name / purpose of visit / date of entry / length of stay and type of visa
- Must have the official seal and include the autograph of the authorised representative (electronic signature is not acceptable)

#### 6. Recommendation Letter issued by educational institution in Japan

- Must be an original Recommendation Letter written in English (PDF or fax copy is not acceptable)
- Must have the letter head of educational institution in Japan
- Must address to "Royal Thai Consulate-General, Osaka"
- Must contain the applicant's name / purpose of visit / date of entry /length of stay and type of visa
- Must have the official seal and include the autograph of the authorised representative (electronic signature is not acceptable)
- **※** In case that the Recommendation Letter from educational institution in Japan cannot be shown, an original guarantee letter must be presented together with a copy of guarantor's passport or driving license duly signed by the guarantor

- A guarantor must be twenty (20) years of age or older, must be able to confirm the applicant's personal attributes. A guarantor must be available to be contacted by the Consulate-General and must not be a person who will accompany the applicant to Thailand
- A guarantor who are not Japanese national must provide a copy of passport and residence card (front and backside) \*Guarantor must be Japanese or non-Japanese who has permanent residence in Japan.)
- A guarantor must sign as the same as the guarantor's identification document signature
- > Japanese guarantor who prefers to use driver license, please sign as the same as signature in the guarantor letter on the copy of driver license (front and backside)

#### 8. Tentative programmes of study or course plan issued by educational institution in Thailand

- Must provide a verifiable and traceable weekly programme of study or course plan
- 9. One copy of receipt payment for the study or course plan

#### 10. One original bank statement of the applicant in English language

- Bank book is not acceptable
- Issued within one month showing the latest details

# 11. Evidence of accommodations for the entire duration of stay in Thailand (one of the following documents from 7.1-7.4 is required)

- 11.1 Hotel reservation
- 11.2 Copy of the applicant's own evidence for condominium / apartment / house
- 11.3 In case of renting condominium / apartment / house, a copy of the lease agreement and landlord's Identification Card (ID Card) is required
- 11.4 In case of staying with friend or family, the following documents from A-D is required
  - A. Invitation Letter from friend or family (including name of the writer, relationship with the applicant, address for staying, length of stay, contact, and signature of the writer)
  - B. In case of owning or renting condominium / apartment / house, a copy of the applicant's own evidence or the lease agreement
  - C. One copy of Identification Card (ID Card) of friend or family
    - ➤ In case of Thai national, must submit a copy of ID card and House Registration which include address and name
    - ➤ In case of foreigner, must submit a copy of passport (photo page and valid visa pages) and, in case of foreigner legally working in Thailand, must also submit a copy of valid work permit
  - D. Official documents proving family relationship
    - ➤ For Japanese national, must submit one original family registration certificate of Japan (KOSEKITOHON) issued within 3 months
    - ➤ For foreigners, must submit one copy of Registration of Marriage with English translation or Birth Certificate with English translation

- Must be written in English language

- For Japanese national, an original Household Registration (KOSEKITOHON) issued within 3 months
- > For Non-Japanese nationality, Residence Records (JUMINHYO) or birth certificate of your country with English translation is required

• The confirmed airline ticket paid in full or ticket reservation confirmation must be issued by airline or travel company and must contain the applicant's name, flight number and date arrival

- For those who are currently applying for renewal of residence card, please submit a copy of acceptance of renewal issued by the Immigration Bureau of Japan
