Visa issuance is under the discretion of the Royal Thai Consulate-General, Osaka. The Royal Thai Consulate General, Osaka reserves the right not to explain the reason of rejection.

- **Submission:** working days from 9:30-11:30 hrs. Please refer to [www.thaiconsulate.jp](http://www.thaiconsulate.jp) for the official holidays of the Royal Thai Consulate-General, Osaka.
- **Collection:** from 13:30-15:00 hrs. 2 working days from submission date in the absence of error in the application form and required documents. (Visa processing time for certain nationals listed in the guideline for visa application published in our website is 45-60 days.)

### Eligibility of the main applicant

1. Must be aged fifty (50) years or over on the date of visa application
2. Must hold passport and nationality of the following country (1) Japan (2) Australia (3) Denmark (4) Finland (5) France (6) Germany (7) Italy (8) the Netherlands (9) Norway (10) Sweden (11) Switzerland (12) United Kingdom (13) Canada (14) United States of America
3. Must not be prohibited from entering Thailand in accordance to the Immigration Act B.E. 2522 (1979)
4. Must not have criminal records in Thailand, Japan and the applicant's native country
5. Must have permanent residence in Japan.
6. Must have no prohibitive diseases as indicated in the Ministerial Regulation No.14 (B.E.2535), namely, Leprosy, Tuberculosis, Elephantiasis, Drug Addiction and Third phase of Syphilis.
7. Must acknowledge that employment in Thailand is strictly prohibited.

### Document Required

**2. Color Photograph(s) affixed to the application form**

- 3 identical color photos taken within the last 6 months, the photo(s) of the applicant should be
  - 3.5cm wide and 4.5cm high
  - facing forward and looking straight at the camera
  - taken against plain light color background
  - taken with a neutral expression and with the mouth closed (no smiling, frowning or raised eyebrows)
  - taken with his/her eyes open and clearly visible (no sunglasses or tinted glasses and no hair across the eyes)

- taken with no other objects or people in the photo
- be clear and in sharp focus without shadows on the picture
- be free from reflection or glare on glasses
- be printed to a high quality, such as photos printed by a booth or studio

### **3. Passport Original and copy**

- At least two blank pages left
- 3 copies of the biodata page (A4 size)

### **5. Original and 2 copies of financial evidence Either one of the two following documents is acceptable:**

- Certificate of bank deposit stating bank contact information, copy of bank book and bank statement which shows fixed deposit with the amount of not less than 3million Baht deposited in Thai bank located in Thailand
- Certificate of bank deposit stating bank contact information, copy of bank book and bank statement which shows fixed deposit with the amount of not less than 1.8 million Baht deposited in Thai bank located in Thailand and certificate of annual income with the amount of not less than 1.2 million Baht (local currency equivalent). (*Once entering Thailand, the applicant must have accumulated money deposited in Thai bank located in Thailand not less than 3 million Baht within 1 year*)

\*The above financial evidence must be issued within 1 month

### **6. Original certificate of criminal record issued within 3 months**

- Certificate of criminal record clearance from competent authority of Japan and the applicant's native country in case the applicant is a foreigner having permanent residence in Japan
- The certificate of criminal record clearance from Japanese authority must be certified (legalized) by the Ministry of Foreign Affairs of Japan and submitted to the Royal Thai Consulate-General, Osaka, in a **sealed envelope**. (Ministry of Foreign Affairs of Japan Osaka Liaison Office: 06-6941-4700)
- The certificate of criminal record clearance from the applicant's native country must be certified (legalized) by the Ministry of Foreign Affairs and the embassy or consulate-general in Japan of the respective country

### **7. Original and 2 copies of medical certificate**

- Issued by a national or public hospital showing that the applicant has no record of the following prohibitive diseases: Leprosy/ Tuberculosis/ Elephantiasis/ Drug addiction/ Third phase of Syphilis
- Must be issued within 3 months
- Must be certified (legalized) by the Ministry of Foreign Affairs of Japan (Ministry of Foreign Affairs of Japan Osaka Liaison Office: 06-6941-4700)

### **8. Original and 2 copies of Thai Health Insurance**

- Health insurance policy must have coverage not less than 400,000 Baht per policy year for inpatient and not less than 40,000 Baht per policy year for outpatient.

### **9. Airline ticket or flight confirmation sheet 3 copies**

Airline ticket or booking confirmation with the applicant's name and flight details (flight number/ date and time of arrival in and departure from Thailand) issued by airline or travel company

\*One-way ticket is not acceptable for non-Japanese nationals
