

Non-immigrant O-X Visa (Long Stay 10 Years)

Please make an appointment online [VABO] at www.thaiconsulate-visa.jp/vabo/ before visa application.

- **Submission:** working days from 9:30-11:30 hrs. Please refer to www.thaiconsulate.jp for the official holidays of the Royal Thai Consulate-General, Osaka.
- **Collection:** from 13:30-15:00 hrs. 2 working days from submission date in the absence of error in the application form and required documents. (Visa processing time for certain nationals listed in the guideline for visa application published on our website is 45-60 days.)

Notice	<ul style="list-style-type: none"> ● Aged fifty (50) years or over at the date of visa application ● Applicant must not be prohibited from entering Thailand , in accordance to the Immigration Act B.E.2522 (1972) ● Applicant must not have criminal records in Thailand, Japan and the applicant's native country ● Applicant must have permanent residence in Japan ● Applicant must hold passport and nationality of the following country (1) Japan, (2) Australia, (3) Denmark, (4) Finland, (5) France, (6) Germany, (7) Italy , (8) the Netherlands, (9)Norway, (10)Sweden, (11) Switzerland, (12) United Kingdom, (13) Canada, (14) United states of America ● Applicant must have no prohibitive diseases as indicated in the Ministerial Regulation No.14 (B.E 2535), namely, Leprosy, Tuberculosis, Elephantiasis, Drug Addiction and Third phase of Syphilis ● Applicant must enter Thailand on the date specified in the airline ticket or ticket reservation confirmation ● Upon arrival to Thailand, the period of stay is granted by an immigration officer in accordance with the type of visa; travelers who wish to stay longer than the granted period must file an application for permission of extension of stay at offices of the Immigration Bureau of Thailand; the extension of stay as well as the change of certain type of visa is solely at the discretion of the Immigration officer in Thailand ● In case that visa application is rejected, the visa fee will not be refunded and the submitted documents will not be returned to the applicant ● The following required documents are subject to change without prior notice ● The Royal Thai Consulate-General, Osaka reserves the right to request additional documents as deemed necessary and reserves the right to reject an application without providing any reasons ● Fraud or misrepresentation can result in permanent visa ineligibility 		

Required Documents

- 1. Passport** Original and copy
 - Passport with validity not less than 18 months
 - At least 2 blank pages left
- 2. One original Visa Application Forms and copy**
 - Two Visa Application Forms completely filled out and signed as the same as the applicant's passport signature

- 3. Two Photographs**
 - Size 3.5 cm × 4.5 cm
 - Colour photograph taken within the last 6 months
 - Attach the photograph to the Visa Application Form
 - Note that the number of photographs required depending on the applicant's nationality, please check the additional required documents for Non-Japanese applicants below
- 4. Two Personal History forms**
 - Two Personal History completely filled out and signed as the same as the applicant's passport signature

- 5. Two copies of confirmed airline ticket paid in full or ticket reservation confirmation**
 - The confirmed airline ticket paid in full or ticket reservation confirmation must be issued by airline or travel company and must contain the applicant's name, flight number and date arrival
- 6. Financial statement**

Please choose one of the following documents (a or b);

(a) Certificate of bank deposit stating bank contact information, copy of bank book and bank statement which shows fixed deposit with the amount of not less than 3million Baht deposited in Thai bank located in Thailand;

(b) Certificate of bank deposit stating bank contact information, copy of bank book and bank statement whichshows fixed deposit with the amount of not less than 1.8 million Baht deposited in Thai bank located in Thailand and certificate of annual income with the amount

*Once entering Thailand, the applicant must have accumulated money deposited in Thai bank located in Thailand not less than 3 million Baht within 1 year.
- 7. Certificate of criminal record** clearance from competent authority of Japan
- 8. One original and one copy of medical certificate issued within three (3) months by a national or public hospital in Japan.**
 - Must showing no prohibitive diseases as indicated in the Ministerial Regulation No.14 (B.E.2535), namely, Leprosy, Tuberculosis, Elephantiasis, Drug Addiction and third phase of Syphilis.
 - Must be certified by the Ministry of Foreign Affairs of Japan or by competent authority of country of the applicant's nationality and presented to the Consulate-General in a sealed envelope.
- 9. Original and 2 copies of Thai Health Insurance**
 - Health insurance policy must have coverage not less than 400,000 Baht per policy year for inpatient and not less than 40,000 Baht per policy year for outpatient. Valid health insurance covers with a minimum coverage of 100,000 USD including medical treatment related to COVID-19 for the intended period of stay in Thailand.

Dependents of Non-Immigrant Visa “O-X” Applicant

- 10.** Dependents of the applicant are entitled to apply for the same visa category. The additional required documents are as follows;

For Spouse (No age restriction)

- Valid Marriage Certificate in English or Japanese House Registration (KOSEKITOHON) issued within 3 months, which are legalized by relevant authorities.
- Required documents listed in No. 1-9 above.

For Child (under 20 years old)

- Valid Birth Certificate in English or Japanese House Registration (KOSEKITOHON) legalized by relevant authorities.
- Required documents listed in No. 1-5 and No.9 above.

Additional documents for non-Japanese applicant:

- 11.** A copy of resident card or certificate of alien registration which is valid for at least 3 months. For those who are currently applying for renewal of residence card, please submit a copy of acceptance of renewal issued by Immigration Bureau of Japan. The applicant is also required to present the original documents of identification upon submitting visa application.

NOTES:

- 1) Documents No. 7-9 must be issued within three (3) months and certified by notary public including the Ministry of Foreign Affairs of Japan or the competent authority of country of the applicant.
- 2) The Embassy reserves the right to request additional documents and reject an application without providing any reasons.
- 3) In case that visa application is reject, the application will not be refunded and submitted documents will not be returned to applicant.
- 4) Holder of Non-Immigrant visa O-X will obtain a multiple-entry with validity of 5 years. The visa holder can submit an application to extend the stay for additional 5 years at the Office of Immigration Bureau <http://www.immigration.go.th>. The extension of stay is solely at the discretion of the Immigration officer.
- 5) Processing time: 2 working days(After submitting the application, if no additional document is requested, the passport with visa will be sent out from the Embassy by post on the next day (pay delivery fee upon delivery)
- 6) Visa Processing Fee is 44,000 Japanese Yen for multiple entries. (CASH only)
- 7) Applicant must apply for visa in person.
