

Tourist Visa

※Required documents for applying a visa in the periods of Coronavirus COVID – 19 outbreak※

Please make an appointment online [VABO] at <http://thaiconsulate-visa.jp/vabo/index.php/en/> before visa application.

The Royal Thai Consulate-General, Osaka may require additional documents and reserves the right to reject incomplete visa application as well as fraud and misrepresentation. Visa issuance is under the discretion of the Royal Thai Consulate-General, Osaka. The Royal Thai Consulate General, Osaka reserves the right not to explain the reason of rejection.

- **Submission:** working days from 9:30-11:30 hrs. Please refer to www.thaiconsulate.jp for the official holidays of the Royal Thai Consulate-General, Osaka.
- **Collection:** from 13:30-15:00 hrs. 2 working days from submission date in the absence of error in the application form and required documents. (Visa processing time for certain nationals listed in the guideline for visa application published in our website is 45-60 days.)

All documents required must be issued within one (1) month.

1. Passport: Not less than 6 months validity with at least 2 blank pages left
2. 1 copy of the bio-data page of the passport
3. Application form affixed with a color photo (size 3.5 x 4.5 cm.) taken within the last 6 months: completed and signed by the applicant (http://www.thaiconsulate.jp/files/user/appli_pdf/application_for.pdf)
4. Personal history: completed and signed by the applicant (<http://site.thaiembassy.jp/upload/pdf/about-visa-personalhistory.pdf>)
5. Original guarantee letter and photocopy of guarantor's passport or driving license duly signed by the guarantor (http://www.thaiconsulate.jp/files/user/appli_pdf/guarantee_letter.pdf)
6. Official bank statement and a copy of bank account of the applicant with the minimum of the latest balance equivalent of 20,000 Thai baht per applicant

7. Return airline ticket or booking confirmation issued by airline with applicant's name, flight number as well as flight date and time

8. Copy of proof of accommodation in Thailand in English or Thai with applicant's name, name and address of accommodation, phone number and length of stay

8.1 Alternative State Quarantine (ASQ) booking confirmation and receipt and

8.2 proof of accommodation after alternative state quarantine

1) hotel reservation

2) in case of rental property, lease agreement with the applicant's name and a copy of the landlord's ID card with his/her signature English or Thai

3) in case of staying with family or friends, applicant must provide the following documents:

- Letter from a guarantor in Thailand, stating the guarantor's name, applicant's name, relationship, address, phone number, length of the applicant's stay and guarantor's signature

- For a Thai guarantor: copy of the guarantor's ID card and housing registration with guarantor's signature.

- For a foreign national guarantor: copy of the guarantor's passport, work permit, stay permit and lease agreement with guarantor's signature plus a copy of the landlord's ID card with his/her signature.

9. Additional required documents for

1) Self-employed person: Original company registration

2) Employee: Original certificate of employment or certificate of leave in English* with the following details is required: - full name of the applicant - employment details: name of the company/ organization, date of joining the company/ organization, current position, affiliation (section/ division/ department, etc.) and monthly salary

*The certificate must be printed on the company's or the organization's letterhead (if the company/ organization has no letterhead, please submit an original company registration), signed by an authorized person and affixed with the seal of the company/ organization.

3) Student: Original certificate of enrollment in English

4) Applicant aged under 20:

- Copy of the parents' passport (both father and mother) with original signature as appeared in the passport

- Original certificate of family register or certificate of residence

Additional documents for non-Japanese applicant:

1. 1 copy of residence card with three-month validity is required. For those who are currently applying for the renewal of the residence card, a copy of acceptance for the renewal issued by the Immigration Bureau of Japan must be submitted
2. Applicants holding passports of Afghanistan, Bangladesh, Egypt, North Korea, Libya, Palestine, Sudan, Yemen, Cameroon, Congo, Republic of Congo, Equatorial Guinea, Guinea, Algeria, China, India, Iraq, Lebanon, Nepal, Pakistan, Sri Lanka, Syria, Ghana, Central African Republic, Somalia, Sao Tome and Principe, Liberia, Sierra Leone, Saudi Arabia, please submit three (3) color photos and three (3) copies of application forms which are duly filled and signed.
3. Applicants holding passport of Nigeria and Iran, please submit four (4) color photos and four (4) copies of application forms which are duly filled and signed.

Remarks: The applicant must enter Thailand on the date specified in the application form and relevant documents at the time of application.
